1. Opening of the Meeting

A. Call to order- Kevin called the meeting to order at 2:06 pm

2. Public Comment

3. Action Item

A. Approval of Minutes - October 12, 2021

4. Discussion Item

A. New Governance Structure - Draft (Yolanda Catano)

- Standing Committees under Integrated Consultation Council and Academic Senate viewed.
- Outcomes and Assessment will provide a report to the Program Review Committee which is under the Institutional Effectiveness and Development Committee (IEDC) in addition to reporting as a subcommittee of Academic Senate.
- A meeting summary report document can be provided as a reporting mechanism; Kevin Howell is also a member of the Program Review Committee and can provide a verbal report.

B. Handbook Approval

- This will go as a second read to the next Academic Senate meeting. No additional feedback was provided by the senate during the first read. Kevin thanked members of the OAC for providing information for the first reading.

C. PSLOs and Student End Goals

- Vision for Success goals were provided by the Chancellor's Office; for our guided pathways work we need to align our institutional learning outcomes with our strategic goals that were developed to align with the vision for success goals. The committee does not necessarily need to use all the strategic goals but make sure that what the students are learning aligns with the ILOs.
- Kevin mentioned that the annual ILO survey of graduating students is aligned with the college ILOs.
- Christina explained that this is like the next step; for example looking at each ILO we would review the strategic goals and determine how they align; make sure that our ILOs help us achieve our strategic goals.
- The committee can begin to look at how these align. Mapping or another method to review how these align would be appropriate. Using mapping can facilitate a change in ILOs based on how they align with the college's Strategic Goals.
- The goal of this topic is to identify the link between ILOs and Strategic Goals.
- Jose Carrillo provided an example of mapping that is being used for the strategic goals. It may be possible to develop a similar mapping capability for this committee to work on (through Nuventive).
- Kevin will work with Christina, Jose, and Yolanda to bring back clarification to the committee, so that work can begin on mapping. Since the next meeting will not be until next Spring Kevin will email members so the work can begin sooner.

5. Information Items

A. Update on SLOs, PLOs, and SAOs

- Spring 21 SLOs have been collected. Fall 21 SLO assessments are being sent out and will be due 6 weeks into the Spring 22 semester.
- All PLO assignments have been sent out to all areas that have comprehensive program reviews due.
- The mapping information can then be used to complete program review.
- Service Area Outcomes have been sent and completed. New departments have been added and they are working on developing SAOs.
- We are currently on target with all SLOs, PLOs, and SAOs.

B. Nuventive Update

- Currently, our mapping will be identified with a check mark; in the future we will have a drop-down with I, E, or A.
- Analytics data are now available on each program page.
